ALUMNI REUNITE FOR 25TH ANNIVERSARY



RHO ATTENDS 2012 DKE CONVENTION AT PSI

The 168th Delta Kappa Epsilon Convention was hosted from July 25-28 by University of Alabama in Tuscaloosa, Alabama. For the first time in recent history, Rho sent a delegation to the biennial convention, giving Brothers **Robert Howe '14** and **William Leonard '14** an opportunity to travel to the Psi Chapter to meet with Dekes from around the country.

Topics discussed at the convention included recruitment, risk management, new member education, ritual, and DKE International's finances. Additionally, Brother Leonard shared that the part of convention that interested him most was listening to the informal presentations given at meals every day. These speakers included Nick Pence, Sigma Kappa '99 (Army Ranger, member of the unit that brought Ayman al-Zawihiri to justice), Bill Kavan, Theta Upsilon '92 (Director of Development at Arizona State University), John McCardell (President Emeritus of Middlebury College, Vice-Chancellor of Sewanee: The University of the South, leader of a group of college presidents that favor returning the drinking age to 18), Robert Witt (Chancellor of the University of Alabama), and Terry Stewart, Phi Chi '69 (President of the Rock and Roll Hall of Fame and former Chairman of the Board of Marvel Comics).



Brother Leonard's take on the 2012 convention proves that the duo's trek (which was marred by delayed flights and missed connections) was certainly worthwhile. "Although chapters differ from school to school, it was quite evident that all the delegates truly were gentlemen, scholars, and jolly-good fellows. We have all kept in touch through Facebook, and I think it's safe to say that we made friendships that will last a lifetime. The convention showed us that our motto 'friends from the heart forever' applies not only to the brothers of our chapter, but to every Deke across North America, regardless of what school they attended and what year they graduated." Linscott Hanson, Omicron '59, a trustee of the Rampant Lion Foundation, reflected on Leonard's comments by saying that "Our fraternity is more than a college experience, it is truly a brotherhood for life."

The convention also served as the venue for announcing the winner of the annual Lion Trophy, awarded to the chapter that exhibits the greatest scholarship, alumni relations, community service, and chapter improvement. This year's trophy was awarded to the Phi Alpha Chapter (University of British Columbia), which has now won this prestigious award five times.

GREEK LIFE ON CAMPUS

Chi Phi Lawsuit

Chi Phi's lawsuit against the College progressed through the courts. In essence, they sought to repopulate their chapter house with current students. This is the latest in a long running dispute between Chi Phi and College leadership about the status of the Chi Phi chapter at Lafayette. The judge is expected to rule on August 31st.

DU Conduct Hearing

This June, Delta Upsilon was charged with co-hosting an unregistered party in early April with the Delta Delta Sorority in DU's chapter house where alcohol was served. Our alumni leadership watched this case carefully with serious concerns about the adjudication process and severity of penalties applied only to fraternities. The student conduct committee initially voted to revoke DU's charter (a power the College does not hold) with no explanation of aggravating factors that led them to set aside the guidelines in the Student Handbook when deciding this case. The Appeals Committee upheld DU's appeal and ordered a rehearing of the case, which is scheduled for early September. DKE will continue to advise DU's alumni and students to the extent that they request our support. We must stand together while holding our community members accountable. To date, no charges have been brought against the Delta Delta Sorority for their role in co hosting the alleged event. We continue to be disappointed at the lack of learning opportunities or student development the College imparts in adjudicating student behavior.

Board of Trustees Direction & LAGGL metrics

The Implementation and Assessment Group on Greek Life (IAGGL) published metrics, which all fraternity and sorority chapters need to meet, following an October 2011 Board of Trustees decision establishing a three year window to measure improvement in the Greek community. That improvement is supposed to emanate from 23 items the Board of Trustees directed the administration to implement with the assistance of faculty and others.

In August, DKE leadership published a dashboard tracking progress towards implementing the Board's 23 directives because we are concerned at the lack of progress after an academic year, which is 1/3 of the Board's timeline. DKE's leadership fears no implementation means no progress for IAGGL's metrics to capture.

Of great concern is that our understanding of the Board's direction is dramatically different than what is actually happening on campus. Notably Professor Averret, the incoming Chair of the Student Conduct Committee, wrote on behalf of the SCC that "the call for increased alumni involvement is merely a recommendation from a campus wide committee and is not in and of itself a college policy." We understand this as part of the Board's direction.

DKE strongly disagrees with the assertion that the Board of Trustees is a "campus wide committee" that can make "merely a recommendation" rather than set college policy. This led us to three possible conclusions:

- 1) We are wrong about the direction the Board provided in October
- 2) Professor Averett is unaware the Board directed the administration & faculty to do anything
- 3) Professor Averett is aware of the direction, but is disregarding it

Fortunately, Jim Dicker (VP of Development and Alumni Relations) and Bob Massa (VP of Communications) took up our concerns. The College should shortly be creating and publishing the Time and Responsibility Grid the Board directed Campus Life to create immediately after their October Board meeting. This will provide community leaders points of contact for each of the 23 items the Board directed for implementation.
